SKIN: REMOVE CONTAMINATED CLOTHES, FLOOD WITH WATER FOR 15 MINUTES.

INHALATION: MOVE VICTIM TO FRESH AIR. GIVE ARTIFICIAL RESPIRATION IF PATIENT IS NOT BREATHING.

7. HANDLING AND STORAGE

HOWEVER, ON A PRACTICAL BASIS AND ACCORDING TO GUIDELINES FOR CLASSIFICATION OF EXPERIMENTAL ANIMAL CARCINOGENS OF THE ACGIH, NTA OR TRISODIUM NITRILOTRIACETATE WOULD NOT BE CONSIDERED AN OCCUPATIONAL CARCINOGEN OF ANY PRACTICAL SIGNIFICANCE.
